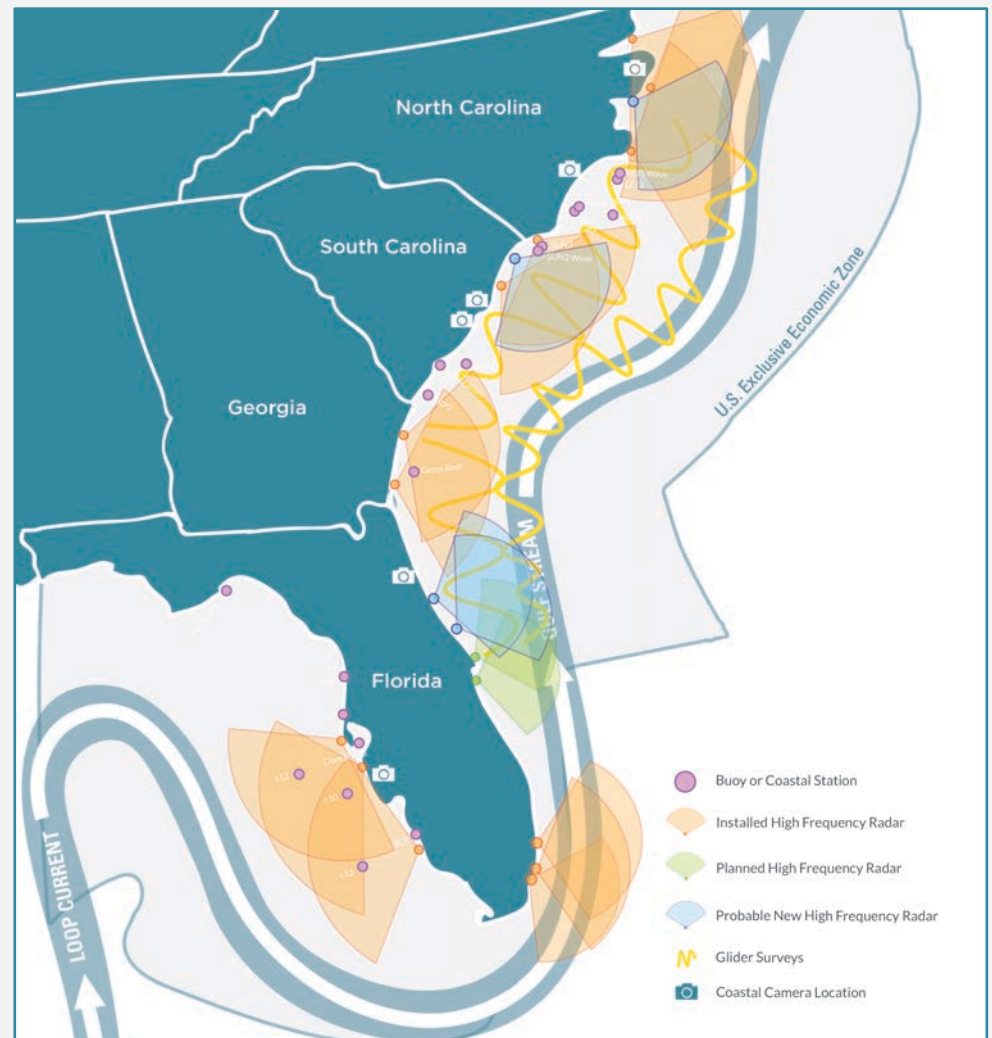

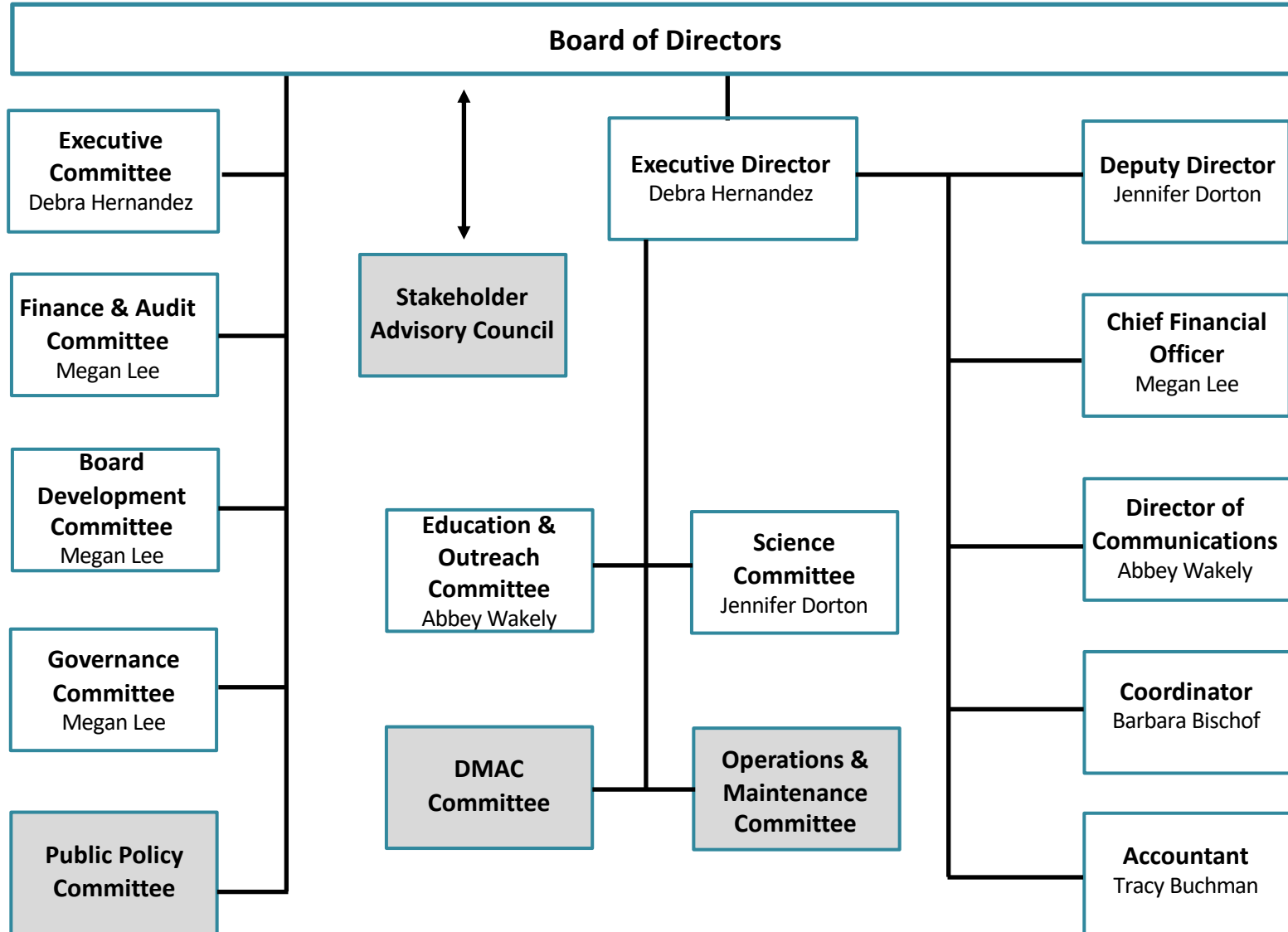

STRATEGIC GOALS

1 Increase exposure and broaden usage of SECOORA's information and products

Strategies:

- Improve web-based information system and web presence.
- Provide state of the art tools, including phone apps, data analysis tools and decision support tools, and information on how to use the tools
- Implement an effective outreach strategy to reach priority user groups, such as mariners, fisheries managers, marine planners, etc.

2 Utilize a prioritized science-justified ocean observing system plan to guide and inform decision making and implementation

Strategies:

- Regularly review status of Coastal Ocean Observing System technologies and advancements
- Develop agreement on the Regional Coastal Ocean Observing System Plan utilizing existing proposal, plans and documents
- Utilize the RCOOS plan for funding opportunities

3 Expand partnerships – including membership and stakeholders

Strategies:

- Outreach to currently under-represented sectors to participate in SECOORA activities and initiatives
- Develop new services, and better market current services, including benefits for members
- Identify and promote opportunities for potential partners (non-members) to engage in SECOORA activities and initiatives

4 Engage and inform students and the public in ocean observing

Strategies:

- Support citizen-science opportunities
- Engage students in problem solving using ocean observing data
- Establish our researchers and program managers as resources for students and the general public
- Identify and pursue cooperative educational funding opportunities

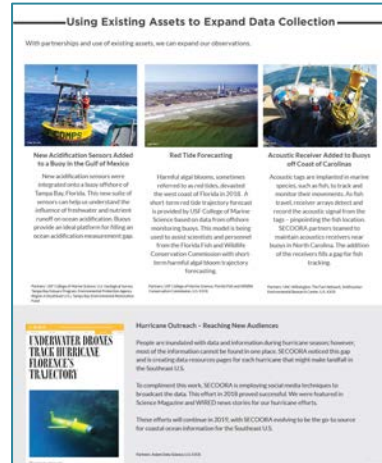
5 Improve SECOORA's organization capabilities

Role of the Board of Directors

Meeting Participation

SECOORA host two in-person Board meetings a year and two Board calls a year (or as needed). SECOORA reimburses for all travel to in-person meetings ([click for travel reimbursement form](#)).

Below is an overview of the schedule
(subject to change).

In Person Meetings

Winter Meeting: Historically held in December or January in different locations. This is a longer meeting focused on program development.

Summer Meeting: Held in conjunction with SECOORA's Annual Meeting. Historically scheduled in May and focuses on program implementation.

Board Conference Calls

Spring Board Call: Held to vote on Board election documents and budget review. Historically scheduled in March.

Summer Board Call: Held to elect Executive Committee officers and provide updates since the last meeting. Historically scheduled in July.

Committees Opportunities

Committees are essential to SECOORA operations. As established by our Bylaws, it is the one of the primary mechanisms by which members interact with and make decisions for the organization. We ask Board members participate on a Committee. There are two types of committees.

Policy Committees

Required to be chaired by a Board member, and membership is approved by the Board.

Program Committees

Serve at the pleasure of the Executive Director and members do not need to be approved, nor chaired by a Board Member. These committees operate more in an advisory capacity. If they decide on activities that require action, they refer them to the Board.
