

Proposal Framework

Overarching Principles:

- Provide hope for improving (growing) the system,
- Recognize ongoing depreciation, and the need for inflationary increases to core operations,
- Reward and value the significant leveraging currently being provided by SECOORA members and partners.

Review Panel recommendations for the inclusion of projects in the proposal reflect the above principles.





Recommendations

The SECOORA IOOS proposal should have the following features:

- regional coverage of a diverse area;
- highest user interest, especially buoy and tower data on which citizens, decision-makers and scientists have come to depend;
- cross-state and intra-regional cooperation; and,
- maintenance of critical in-water infrastructure, its data connectivity to shore and proven technical talent.

Topic Area 2: "National Scale Efforts Toward Evaluation of Observing Technologies" in the FY 2016 U.S. IOOS FFO

- IOOS FFO: Validation and Verification of Observing Technologies
- Request for LOIs: March 11 April 15 (Two received)
- Anticipated Number of Awards : ONE
- Funding Amount/Period: 1 3 Million per year/ Five Year
- Salient Points:
 - Test and Evaluate Sensors in different environments (Field and Lab Environments)
 - Responds to testing activity included in National Waves Plan and/or National Surface Current Mapping Plan
 - Can apply results to multiple regions nationally
 - Builds Capacity related to the use of sensors for COOS
- Next Steps: Review of received LOIs against the FFO requirements; Determine the fit with SECOORA capabilities; Make decision to submit a proposal
- Time Frame, if decide to go ahead June 1 August 15, 2015

 - Replace the words "National Federation of Regional Associations" with "IOOS Association"








